SINCE OUR FOUNDING IN 2003, WE HAVE PRODUCED 33 WORLD PREMIERE PLAYS, INCLUDING 2017'S "THE HOUSE IN SCARSDALE: A MEMOIR FOR THE STAGE" BY DAN O'BRIEN. OUR 2017 THEATRE SEASON WON THE POLLY WARFIELD AWARD FOR EXCELLENT SEASON FROM THE LOS ANGELES DRAMA CRITICS CIRCLE.
